Ordinance 11-06

An Ordinance of a Budget Transfer and Supplemental Appropriation for Health and Human Services of the Executive Branch of Tribal Government and Circle of Health for Fiscal Year ending September 30, 2005.

The District II Representative introduced the following Bill on the 15th day of December, 2005.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2005.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and Budget Transfers for Health and Human Services and Circle of Health for fiscal year ending September 30, 2005.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five hundred two thousand seven hundred thirty dollars and sixty seven cents (\$502,730.67) for fiscal year 2005 shortage, under Circle of Health; One hundred nineteen thousand one hundred forty dollars and no cents (\$119,140.00) additional Self Governance funds, under Health and Human Services; which ends the Total Fiscal Year 2005 Tribal Operations to read One hundred five million one hundred thirty six thousand five hundred eighty seven dollars and twenty four cents (\$105,136,587.24).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
