Ordinance 18-07

An Ordinance of Supplemental Appropriation for Housing Initiative, Administration, Department of Justice and Health and Human Services of the Executive Branch of the Tribal Government for Fiscal Year ending September 30,2007.

The District I Representative introduced the following Bill on the 6th day of February 2007.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2007.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Housing Initiative, Administration, Department of Justice and Health and Human Services for fiscal year ending September 30, 2007.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six hundred fifty-five thousand seven hundred ninety two dollars and ninety-seven cents (\$655,792.97) under **Housing Initiative**; and

Ninety thousand seven hundred thirty dollars and no cents (\$90,730.00) for child care assistance reimbursement from the State, Sixty five thousand eight hundred fifty six dollars and no cents (\$65,856.00) for MFIP additional funds for calendar year January 1, 2007 – January 31, 2007, Five hundred seventeen thousand five hundred eighty five dollars and no cents (\$517,585.00) for federal TANF funds, under **Administration**; Two hundred forty nine thousand six hundred eighty dollars and no cents (\$249,680.00) for Special Diabetes grant 220-415, Seven thousand five hundred dollars and no cents (\$7,500.00) for Emergency Preparedness 220-499 additional grant, Forty five thousand eight hundred eighteen dollars and sixty cents (\$45,818.60) for Contract Health 220-421 unspent FY '06 self-gov funds, Two hundred thirty nine thousand nine hundred four dollars and no cents (\$239,904.00) for Department of Justice grant, Twenty six thousand six hundred sixty seven dollars and no cents (\$26, 667.00) for cash match, under **Health & Human Services**; which amends the **Total Fiscal Year 2007 Tribal Operations** to read Ninety-three million six hundred forty-seven thousand six hundred twenty-two dollars and eighty five cents (\$93,622,643.85).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
