Ordinance 31-07

An Ordinance of Supplemental Appropriation, and Budget Revision for Community Development, Health and Human Services and Natural Resources of the Executive Branch of the Tribal Government for Fiscal Year ending September 30, 2007.

The District I Representative introduced the following Bill on the 31st day of May, 2007.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2007.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Community Development, Health and Human Services and Natural Resources for fiscal year ending September 30, 2007.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Twenty one thousand eight hundred thirty dollars and no cents (\$21,830.00) for Title VI, Part C (Caregivers Support) 220-463, under **Health and Human Services**; which amends the **Total Fiscal Year 2007 Tribal Operations** to read Ninety-four million seven hundred one thousand two hundred twenty-five dollars and seventy cents (\$94,701,225.70).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.02.1: The Band Assembly hereby authorizes the transfer of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
