Ordinance 39-07

An Ordinance of Supplemental Appropriation for Health and Human Services and Legislative of the Tribal Government for Fiscal Year ending September 30, 2007.

The District III Representative introduced the following Bill on the 7th day of August, 2007.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2007.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Health and Human Services and Legislative for fiscal year ending September 30, 2007.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Four hundred thousand sixty-four dollars and no cents (\$400,064.00) for **Health and Human Services**; Fifteen thousand dollars and no cents (\$15,000.00) for **Legislative**; which amends the **Total Fiscal Year 2007 Tribal Operations** to read Ninety-seven million seventy-eight thousand eight hundred eighty- five dollars and twenty-nine cents (\$97,078,885.29).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
