Ordinance 15-07

An Ordinance of Carryover Appropriation for Community Development and Gaming Regulatory Authority and Supplemental Appropriation for Health and Human Services of the Executive Branch of the Tribal Government for Fiscal Year ending September 30,2007.

The District I Representative introduced the following Bill on the 25th day of January 2007.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2007.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Community Development, Gaming Regulatory Authority, and Health & Human Services for fiscal year ending September 30, 2007.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two hundred fifty-four thousand four hundred and one dollars and ninety-eight cents (\$254,401.98) under Community Development; Forty-three thousand thirty-five dollars and seventy-five cents (\$43,035.75) for Gaming Regulatory Authority under Economic Development; One hundred sixteen thousand three hundred thirty-nine dollars and no cents (\$116,339.00) under Health & Human Services; which amends the Total Fiscal Year 2007 Tribal Operations to read Ninety-two million eight hundred ninety-six thousand four hundred eighty-eight dollars and twenty-five cents (\$92,896,488.25).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or <u>greater</u>.

All funds appropriated are maximum fund amounts and shall not be exceeded.
