Ordinance 42-07

An ordinance of Supplemental Appropriation, Budget Revision and Budget Transfers for the Legislative, Executive, Judicial Branch, Health and Human Services, Natural Resources, Permanent Initiative, Circle of Health, Community Development, Gaming Regulatory Authority and Education of the Tribal Government for Fiscal Year ending September 30, 2007.

The District III Representative introduced the following Bill on the 30th day of August 2007.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2007.

Title I

Section 1: Government Operations. The Band Assembly hereby appropriates and authorizes expenditures for Legislative, Executive, Judicial Branch, Health and Human Services, Natural Resources, Permanent Initiative, Circle of Health, Community Development, Gaming Regulatory Authority and Education for fiscal year ending September 30, 2007.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: One million dollars and no cents (\$1,000,000.00) from Permanent Initiative for the **Circle of Health**; which amends the **Total Fiscal Year 2007** to read Twelve million eight hundred seventy seven thousand nine hundred fifty nine dollars and no cents (\$12,877,959.00).

five hundred sixty nine thousand seven hundred ten dollars and no cents (\$569,710.00) for Grant Funds, **under Education**; three hundred seventy-six thousand nine hundred fifty-seven dollars and forty-three cents (\$376,957.43) for grant funds under **Health and Human Services**; twenty-six thousand five dollars and no cents (\$26,005.00) for grant funds under **Natural Resources**; which amends the **Total Fiscal Year 2007 Tribal Operations** to read Seventy seven million three hundred fifty nine thousand one hundred nine dollars and forty seven cents (\$77,359,109.47).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
