Ordinance 29-07

An Ordinance of Supplemental Appropriation, Budget Revision and Budget Transfer for Administration, Circle of Health, Department of Justice and Education of the Executive Branch of the Tribal Government for Fiscal Year ending September 30, 2007.

The District II Representative introduced the following Bill on the 1st day of May, 2007.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the fiscal year ending September 30, 2007.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Circle of Health, Department of Justice and Education for fiscal year ending September 30, 2007.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Eighty thousand dollars and no cents (\$80,000.00) for Consultant Contracts 226-4300, Forty thousand dollars and cents (\$40,000.00) for Legal Expenses 226-5100, Five thousand dollars and no (\$5,000.00) for Funds received from T.R.I.A.D and H.O.N.O.R-100-266, Two-hundred-twenty-five-thousand one-hundred-sixty two-dollars and no cents (\$225,162.00) for Child Support enforcement Grant 280-625, under Administration; Two thousand three hundred ninety nine dollars and eighty five cents (\$2,399.85) for Bullet Proof Vest Grant, under Department of Justice; which amends the Total Fiscal Year 2007 Tribal Operations to read Fifty-five million five hundred ninety five thousand five hundred forty nine dollars and eighty five cents (\$55,595,549.85).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
