

Ordinance 59-08

An Ordinance of Supplemental Appropriation from Permanent Initiative and All Band Member Deferred Compensation Fund for Elder Supplemental Income Program of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2008.

The District I Representative introduced the following Bill on the 4th day of December, 2007. The Bill was vetoed on December 9, 2007, and compromise hearings were held on December 18, 2007 and on January 30, 2008. A compromise was reached and the Bill was re-introduced on January 31, 2008. The Bill was vetoed a second time on February 5, 2008, and a compromise hearing was held on February 12, 2008. A compromise was reached and the Bill was re-introduced on February 14, 2008.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating Permanent Initiative and All Band Member Deferred Compensation funds for Fiscal Year ending September 30, 2008.

Title I

Section 1: Permanent Initiative and All Band Member Deferred Compensation Fund. The Band Assembly hereby appropriates and authorizes expenditures for the Elder Supplemental Income Program for Fiscal Year ending September 30, 2008.

Section 1.01: Amendment to Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of: Eight million five hundred thousand dollars and no cents (\$8,500,000.00) from Permanent Initiative Fund for the Elder Supplemental Income Program which amends the **Total Fiscal Year 2008 Permanent Initiative** to read Eight million eight hundred sixty thousand dollars and no cents (\$8,860,000.00); and Two hundred seventy thousand dollars and no cents (\$270,000.00) from the All Band Member Deferred Compensation Fund for the Elder Supplemental Income Program which amends the **Total Fiscal Year 2008 All Band Member Deferred Compensation Fund** to read Two hundred seventy thousand dollars and no cents (\$270,000.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
