Ordinance 72-08

An Ordinance of Supplemental Appropriation and Budget Revisions for Administration, Health and Human Services, Education, Natural Resources of the Tribal Government for Fiscal Year ending September 30, 2008.

The District I Representative introduced the following Bill on the 4th day of March, 2008.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2008.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Health and Human Services, Education, Natural Resources and Permanent Initiative for Fiscal Year ending September 30, 2008.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two hundred eighty six thousand sixty six dollars and no cents (\$286,066.00) for MFIP grant funds 280-636, under **Administration**; Ten thousand three hundred thirty nine dollars and no cents (\$10,339.00) for Weatherization Program EAP/WX 08 grant funds 220-496, Two thousand nine hundred seventy six dollars and no cents (\$2,976.00) for Propane 220-490, Thirty two thousand one dollar and twenty seven cents (\$32,001.27) for Pharmacy 220-424, Thirty two thousand one dollars and twenty six cents (\$32,001.26) for Contract Health 202-421, under **Health and Human Services**, Thirteen thousand nine hundred nine dollars and no cents (\$13,909.00) for ECFE grant funds 201-359, under **Education**; which amends the **Total Fiscal Year 2008 Tribal Operations** to read Seventy one million thirty five thousand forty two dollars and twenty three cents (\$71,035,042.23), and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
