### Ordinance 76-08

An Ordinance of Supplemental Appropriation and Budget Revision for Education, Health and Human Services, and Tribal Police of the Tribal Government for Fiscal Year ending September 30, 2008.

The District I Representative introduced the following Bill on the 1st day of May, 2008.

#### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2008.

#### Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Education, Health and Human Services, and Tribal Police for Fiscal Year ending September 30, 2008.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two Thousand two hundred dollars and no cents (\$2,200.00) for Early Childhood 201-364, under **Education**; Fourteen thousand nine hundred fifteen dollars and fifty cents (\$14,915.50) for Tribal Police 100-160, Twenty five thousand five hundred twenty six dollars and thirty one cents (\$25,526.31) for Public Safety 100-175, under **Tribal Police**; Seventy four thousand three hundred eighty dollars and fifty cents (\$74,380.50) for TANF Home Visiting Public Health Grant 220-458, Forty three thousand eight hundred forty one dollars and forty two cents (\$43,841.42) for Health Disparities 220-457, Fifty thousand seven hundred sixty eight dollars and no cents (\$50,768.00) for Maternal Child Health 220-441, Twenty eight thousand two hundred ninety dollars and no cents (\$28,290.00) for caregivers Support 220-463, Sixteen thousand three hundred thirty nine dollars and no cents (\$16,339.00) for Food commodities 220-452, Two thousand dollars and no cents (\$2,000.00) for MCT CITGO 220-454, under **Health and Human Services**, which amends the **Total Fiscal Year 2008 Tribal Operations** to read Seventy one million seven hundred seventy thousand five hundred thirty nine dollars and eighty five cents (\$71,770,539.85); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs up to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers over \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of up to 50% of the total programs budget within a given budget line if the program is under \$100,000.00 and up to 20% if the program is \$100,000.00 or greater.
