Band Assembly Bill 13-01-65-08

A Bill of Appropriation from the Economic Development fund for Gaming Regulatory Authority for Fiscal Years ending September 30, 2008 and September 30, 2009.

The District II Representative introduced the following Bill on the 17th day of January, 2008.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operation for the Fiscal Years ending September 30, 2008 and September 30, 2009.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Gaming Regulatory Authority for Fiscal Year ending September 30, 2008 and September 30, 2009.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Four million seven hundred forty seven thousand two hundred twenty two dollars and no cents (\$4,747,222.00) (exhibit A) for Gaming Regulatory Authority, under **Economic Development**; which brings the **Total Fiscal Year 2008 Economic Development Fund** to read Nine million six hundred ninety two thousand five hundred seventeen dollars and no cents (\$9,692,517.00); and

Four million nine hundred eighty six thousand nine hundred forty dollars and no cents (\$4,986,940.00) for Gaming Regulatory Authority, under Economic Development; which brings the Total Fiscal Year 2009 Economic Development Fund to read Four million nine hundred eighty six thousand nine hundred forty dollars and no cents (\$4,986,940.00).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds and carryover for the following:

Fiscal Year 2008SupplementalGaming Regulatory Authority\$4,747,222.00

Fiscal Year 2009SupplementalGaming Regulatory Authority\$4,986,940.00

Section 1.03: The Band Assembly hereby authorizes the Executive Director to approve budgetary transfers within programs <u>up</u> to \$5,000.00, if sufficient funds are available for the transfer. For transfers <u>over</u> \$5,000.00, the Band Assembly must approve such transfers.

All funds appropriated are maximum fund amounts and shall not be exceeded.
