#### Ordinance 52-08

An Ordinance of Supplemental Appropriation, Budget Transfer and Budget Revision for Judicial, Health and Human Services and Gaming Regulatory Authority of the Tribal Government for Fiscal Years ending September 30, 2007 and September 30, 2008.

The District III Representative introduced the following Bill on the 30<sup>th</sup> day of October 2007.

#### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for governmental operations for the Fiscal Years ending September 30, 2007 and September 30, 2008.

### Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Judicial and Health and Human Services for Fiscal Years ending September 30, 2007 and September 30, 2008.

Section 1.01: The Band Assembly hereby appropriates and authorizes the expenditures of: Five thousand one hundred thirty dollars and no cents (\$5,130.00) for Contract Health 220-421, under **Health and Human Services**, which amends the **Total Fiscal Year 2007 Tribal Operations** to read Seventy nine million seventy thousand fuve hundred ninety seven dollars and sixty two cents (\$79,070,597.62), and

One hundred forty nine thousand one hundred dollars and no cents (\$149,100.00) for TCAP grant, under **Judicial**, three thousand five hundred nineteen dollars and no cents (\$3,519.00) for EAP State Grant 453, seven hundred thirty four dollars and no cents (\$734.00) for EAP State Grant 453, twenty five thousand four hundred thirty two dollars and no cents (\$25,432.00) for Women's Project 220-495; which amends the **Total Fiscal Year 2008 Tribal Operations** to read Sixty eight million five hundred forty six thousand fifty three dollars and no cents (\$68,546,053.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
