

## Ordinance 50-09

An Ordinance of Appropriation for the Department of Athletic Regulations of the Mille Lacs Band Tribal Government for fiscal years ending September 30, 2010 and September 30, 2011.

The District III Representative introduced the following Bill on the 23<sup>rd</sup> day of September, 2009.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from taxation revenue and ticket sales, for the Department of Athletic Regulations purposes for the fiscal years ending September 30, 2010 and September 30, 2011.

### Title I

**Section 1: Taxation Revenue and Ticket Sales.** The Band Assembly hereby appropriates and authorizes expenditures for the Department of Athletic Regulations for fiscal years ending September 30, 2010 and September 30, 2011.

**Section 1.01: Amendment to Section 1.02:** The Band Assembly hereby appropriates and authorizes the expenditures of: One hundred thirty eight thousand two hundred twenty one dollars and no cents (\$138,221.00) from Taxation; which amends the **Total Fiscal Year 2010 Taxation Revenue** to read Eight hundred thirty eight thousand two hundred twenty one dollars and no cents (\$838,221.00) and Fifty five thousand dollars and no cents (\$55,000.00) from non-comped boxing event ticket sales which amends the **Total Fiscal Year 2010 Ticket Sales** to read Fifty five thousand dollars and no cents (\$55,000.00). See "Exhibit A".

The Band Assembly hereby appropriates and authorizes the expenditures of: One hundred thirty seven thousand five hundred sixty three dollars and no cents (\$137,563.00) from Taxation; which amends the **Total Fiscal Year 2011 Taxation Revenue** to read Eight hundred thirty seven thousand five hundred sixty three dollars and no cents (\$837,563.00) and Fifty five thousand dollars and no cents (\$55,000.00) from non-comped boxing event ticket sales which amends the **Total Fiscal Year 2011 Ticket Sales** to read Fifty five thousand dollars and no cents (\$55,000.00). See "Exhibit A".

**Section 1.02: Amendment to Section 1.03.** The Band Assembly hereby appropriates and authorizes the expenditure of funds for the following:


Section 1.03: The Band Assembly hereby authorizes the Executive Director to approve budgetary transfers within programs up to \$5,000.00, if sufficient funds are available for the transfer. For transfers over \$5,000.00, the Band Assembly hereby must approve such transfers.

All funds appropriated are maximum fund amounts and shall not be exceeded.
