Ordinance 35-09

An Ordinance of Supplemental Appropriation, Budget Revisions and Budget Transfers for Department of Justice and Gaming Regulatory Authority of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2009.

The District III Representative introduced the following Bill on the 30th day of June, 2009.

Preamble

It is enacted by the assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2009.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Department of Justice and Gaming Regulatory Authority for Fiscal Year ending September 30, 2009.

Section 1.01: Amendment to Section 1.02. Twenty two thousand four hundred forty two dollars and eighty one cents (\$22,442.81) from 100-188-3200 revenue under **Gaming Regulatory Authority**, which amends the **Total Fiscal Year 2009 Tribal Operations** to read: Four million, six hundred forty one thousand, nine hundred seventy three dollars and eighty four cents (\$4,641,973.84); and

Two hundred sixty thousand dollars and no cents (\$260,000.00) for Band Member Indian Legal Assistance building under **Permanent Initiative**, which amends the Total Fiscal Year 2009 Operations to read: Seven million one hundred sixty six thousand six hundred thirty seven dollars and no cents (\$7,166,637.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or <u>greater</u>.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant terms so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the grant is not completed within Fiscal Year 2009. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.
