An ordinance of Supplemental Appropriation from Un-Spent Net Revenue for Secretary-Treasurer under the Legislative Branch of the Tribal Government for Fiscal Year ending September 30, 2010.

The District I Representative introduced the following Bill on the 12th day of November, 2009.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2010.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Secretary-Treasurer for Fiscal Year ending September 30, 2010.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Fifty thousand dollars and no cents (\$50,000.00) for Legal Defense 140-5101(from Un-Spent Net Revenue), under Legislative which amends the Total Fiscal Year 2010 Tribal Operations to read Seventy one million one hundred three thousand four hundred twenty dollars and thirty eight cents (\$71,103,420.38); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
