

Ordinance 02-10

An Ordinance of Supplemental Appropriation from Economic Development for High Speed Railway for Fiscal Years ending September 30, 2010 and September 30, 2011.

The District III Representative introduced the following Bill on the 3rd day of November, 2009.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for High Speed Railway 2-year contract for the Fiscal Years ending September 30, 2010 and September 30, 2011.

Title I.

Section 1: Economic Development. The Band Assembly hereby appropriates and authorizes expenditure from Economic Development for Fiscal Years ending September 30, 2010 and September 30, 2011.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: One hundred thousand dollars and no cents (\$100,000.00) for High Speed Railway first year of a 2- year contract (\$48,000/dues and \$52,000 for consultant fees), under **Economic Development**, which amends the **Total Fiscal Year 2010 Economic Development** to read Two million three thousand eight hundred eighty nine dollars and no cents (\$2,003,889.00) and

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: One hundred thousand dollars and no cents (\$100,000.00) for High Speed Railway second year of a 2-year contract (\$48,000/dues and \$52,000 for consultant fees), under **Economic Development**, which amends the **Total Fiscal Year 2011 Economic Development** to read One hundred thousand dollars and no cents (\$100,000.00) and

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:
