

Ordinance 06-10

An ordinance of Supplemental Appropriation for Adult Band Member Economic Stimulus Payments from Taxation Account for Fiscal Year ending September 30, 2010.

The District II Representative introduced the following Bill on the 12th day of November, 2009.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from Taxation Revenue for Adult Band Member Economic Stimulus Payments for the fiscal year ending September 30, 2010.

Title I.

Section 1: Taxation Revenue: Adult Band Member Economic Stimulus Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Stimulus Payments – November 2009, from Taxation Revenue, for fiscal year ending September 30, 2010.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Taxation Revenue of: Two million nine hundred thousand dollars and no cents (\$2,900,000.00) for Adult Band Member Economic Stimulus Payments, under **Taxation Revenue**; which amends the **Total Fiscal Year 2010 Taxation Revenue** to read Three million ninety three thousand two hundred twenty one dollars and no cents (\$3,093,221.00); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
