

Ordinance 35-10

An Ordinance of Supplemental Appropriation for Tribal Per Capita Distributions for Fiscal Year ending September 30, 2010.

The District III Representative introduced the following Bill on the 23rd day of June, 2010.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Tribal Per Capita Distributions for the fiscal year ending September 30, 2010.

Title I.

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for Bonus Distributions (August 2010 – November 2010, see schedule attached) for fiscal year ending September 30, 2010.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: seven million six hundred seventy six thousand eight hundred seventy nine dollars and no cents (\$7,676,879.00) for Adult distributions, four million four thousand dollars and no cents (\$4,004,000.00) for Minor distributions, four thousand one hundred twenty one dollars and no cents (\$4,121.00) for Administration costs under **Bonus Distribution**; which amends the **Total Fiscal Year 2010 Tribal Distributions** to read Thirty five million five hundred forty five thousand dollars and no cents (\$35,545,000.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:


