Ordinance 22-10

An ordinance of Supplemental Appropriation and Budget Transfers for Education, Natural Resources, Administration, Health & Human Services, Community Development, and Office of the Solicitor General of the Mille Lacs Band Tribal Government for Fiscal Years ending September 30, 2010 and September 30, 2011.

The District I Representative introduced the following Bill on the 3rd day of March, 2010.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Years ending September 30, 2010 and September 30, 2011.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Health & Human Services, and Community Development for Fiscal Years ending September 30, 2010 and September 30, 2011.

Section 1.01: Amendment to Section 1.02: One million eight hundred two thousand five hundred thirty three dollars and eighty cents (\$1,802,533.80) for Higher Education Scholarship 201-314 from unspent net revenue under Education; Two hundred eight thousand two hundred thirty six dollars and thirty cents (\$208,236.30) for Administration 100-220 FY 2009 self governance funds carryover under Administration; One hundred eighty five thousand dollars and no cents (\$185,000.00) Scholarships 201-314 FY 2010 self governance funds. Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or <u>greater</u>.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant terms so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the grant is not completed within Fiscal Year 2010. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.
