

Ordinance 04-10

An Ordinance of Supplemental Appropriation for Legislative/Annual Pow Wow of the Mille Lacs Band Tribal Government for Fiscal Years ending September 30, 2010 and September 30, 2011.

The District I Representative introduced the following Bill on the 24th, day of November, 2009.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Years ending September 30, 2010 and September 30, 2011.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Legislative/Annual Pow Wow for Fiscal Years ending September 30, 2010 and September 30, 2011.

Section 1.01: Amendment to Section 1.02. One hundred eight thousand dollars and no cents (\$108,000.00) Annual Pow Wow 100-107, under **Legislative** which amends the **Total Fiscal Year 2010 Tribal Operations** to read: Seventy million five hundred sixty three thousand four hundred one dollars and ninety nine cents (\$70,563,401.99); and

One hundred eight thousand dollars and no cents (\$108,000.00) for Annual Pow Wow 100-107, under **Legislative** which amends the **Total Fiscal Year 2011 Tribal Operations** to read: Seven million four hundred sixty five thousand dollars and no cents (\$70,671,401.99).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:





Band Assembly Bill 13-04-04-10

A Bill of Supplemental Appropriation for Legislative/Annual Pow Wow of the Mille Lacs Band Tribal Government for Fiscal Years ending September 30, 2010 and September 30, 2011.

The District I Representative introduced the following Bill on the 24th, day of November, 2009.

Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Years ending September 30, 2010 and September 30, 2011.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Legislative/Annual Pow Wow for Fiscal Years ending September 30, 2010 and September 30, 2011.

Section 1.01: Amendment to Section 1.02. One hundred eight thousand dollars and no cents (\$108,000.00) Annual Pow Wow 100-107, under **Legislative** which amends the **Total Fiscal Year 2010 Tribal Operations** to read: Seventy million five hundred sixty three thousand four hundred one dollars and ninety nine cents (\$70,563,401.99); and

One hundred eight thousand dollars and no cents (\$108,000.00) for Annual Pow Wow 100-107, under **Legislative** which amends the **Total Fiscal Year 2011 Tribal Operations** to read: Seven million four hundred sixty five thousand dollars and no cents (\$7,465,000.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:
