

Ordinance 10-10

An Ordinance of Supplemental Appropriation from Permanent Initiative of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2010.

The District II Representative introduced the following Bill on the 4th day of December, 2009.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2010.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures from Permanent Initiative for Fiscal Year ending September 30, 2010.

Section 1.01: Amendment to Section 1.02. Nine hundred fifty thousand dollars and no cents (\$950,000.00) for District II land acquisition 250-595 under **Permanent Initiative**, which amends the **Total Fiscal Year 2010 Permanent Initiative** to read: Eight million four hundred fifteen thousand dollars and no cents (\$8,415,000.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:


