Ordinance 20-10

An ordinance of Supplemental Appropriation and Budget Transfers for Education, Natural Resources, Administration, Health & Human Services, Department of Justice, Permanent Initiative and Housing Initiative of the Mille Lacs Band Tribal Government for Fiscal Years ending September 30, 2009 and September 30, 2010.

The District II Representative introduced the following Bill on the 16th day of February, 2010.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Years ending September 30, 2009 and September 30, 2010.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Education, Administration, Health & Human Services, Natural Resources, Department of Justice, Permanent Initiative and Housing Initiative for Fiscal Years ending September 30, 2009 and September 30, 2010.

Section 1.01: Amendment to Section 1.02: Two hundred sixty one thousand nine hundred fourteen dollars and no cents (\$261,914.00) for MFIP 280-636 grant funds under Administration; Sixty two thousand four hundred one dollars and no cents (\$62,401.00) Maternal Child Health 220-441 grant funds, Fifty seven thousand five hundred thirty nine dollars and no cents (\$57,539.00) Eliminating Health Disparities 220-457 grant funds, one hundred twenty thousand one hundred forty eight dollars and no cents (\$120,148.00) Home visiting/ Teen Pregnancy 220-458 grant funds, under Health & Human Services; Twenty seven thousand eight hundred fifty dollars and no cents (\$27,850.00) as a reimbursement share amount through HSEM Regional Coordinator's Office of MN Dept. of Public Safety under Department of Justice which amends the Total Fiscal Year 2010 Tribal Operations to read: Seventy eight million one hundred eight thousand seven hundred twenty nine dollars and thirty five cents (\$78,108,729.35); and

Twenty nine thousand two hundred two dollars and seventy five cents (\$29,202.75) for fiscal year '09 Child Nutrition 201-324 reimbursement funds; under **Education** which amends the **Total Fiscal Year 2009 Tribal Operations** to read: Eighty one million two hundred forty one thousand six hundred eighty five dollars and seventy seven cents (\$81,241,685.77) and

Sixty five thousand dollars and no cents (\$65,000.00) CDFI Development NEW for development of non-profit and CDFI, under **Permanent Initiative** which amends the **Total Fiscal Year 2010 Permanent Initiative** to read: Eight million four hundred eighty thousand dollars and no cents (\$8,480,000.00).

Fourteen thousand eight hundred dollars and no cents (\$14,800.00) Housing Initiative 100-235 for purchase of elder buy back home under **Housing Initiative**, which amends the **Total Fiscal Year 2010 Housing Initiative** to read: Twenty one million four hundred twenty thousand eight hundred forty seven dollars and seventy eighty cents (\$21,420,847.78).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary transfers within programs <u>up</u> to \$10,000.00 provided that the transfers are allowable under grant provisions, if applicable and that sufficient funds are available for the transfer. For transfers <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget transfers within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or <u>greater</u>.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant terms so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the grant is not completed within Fiscal Year 2010. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.04:1 All funds appropriated for capital construction projects shall be appropriated to align with the project length and will no longer automatically carry-over to the next Fiscal Year. If appropriated funds remain and if the project is not completed within Fiscal Year 2010 capital construction projects shall be re-appropriated. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified so as to take appropriate action.
