Ordinance 04-11

An ordinance of Supplemental Appropriation from Unspent Net Revenue for Judicial and Department of Justice of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2011.

The District I Representative introduced the following Bill on the 15th day of February, 2011.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2011.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Judicial and Department of Justice for Fiscal Year ending September 30, 2011.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five thousand one hundred ninety dollars and no cents (\$5,190.00) for Self governance reprogramming funds 100-150 grant under **Judicial**; Sixty thousand dollars and no cents (\$60,000.00) from unspent net revenue 100-215 for Hamilton Quigley & Twait legal contract to establish a Tribal Law & Order Act under **Department of Justice**; which amends the **Total Fiscal Year 2011 Tribal Operations** to read seventy three million thirty five thousand six hundred eighty one dollars and fifty eight cents (\$73,035,681.58);

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2011. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

All funds appropriated are maximum fund amounts and shall not be exceeded.
