### Ordinance 08-11

An Ordinance of Supplemental Appropriation and Budget Revision for Administration, Community Development, Education, Health and Human Services, and Permanent Initiative of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2011.

The District I Representative introduced the following Bill on the 29th day of March, 2011.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2011.

### Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Community Development, Education, Health and Human Services and Permanent Initiative for Fiscal Year ending September 30, 2011.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Fourteen thousand ninety eight dollars and no cents (\$14,098.00) for Tribal Child Support Enforcement 280-625 grant under Administration; Fourteen thousand four hundred five dollars and no cents (\$14,405.00) for Child Care Development grant 201-366; under Education; One hundred thousand dollars and no cents (\$100,000.00) for Aazhoomog Med/Nsg/Lab 220-402 IHS self governance funding; One hundred thousand dollars and no cents (\$100,000.00) for East Lake Clinic 220-405; Ten thousand dollars and no cents (\$10,000.00) for Provider 220-417; One hundred thousand dollars and no cents (\$100,000.00) for Lab/X-ray 220-418; Fifty thousand dollars and no cents (\$50,000.00) for Med Overhead 220-419; One hundred sixty thousand dollars and no cents (\$160,000.00) for Clinic Nursing 220-420; Two hundred ten thousand dollars and no cents (\$210,000.00) for Contract Health 220-421; Thirty two thousand five hundred dollars and no cents (\$32,500.00) for Clinic O & M 220-422; Seven hundred eighty three thousand five hundred thirty five dollars and no cents (\$783,535.00) for Clinic Admin. 220-423; One hundred forty thousand dollars and no cents (\$140,000.00) for Dental 220-425; Twenty five thousand dollars and no cents (\$25,000.00) for ALU O & M 220-437; Two hundred twenty nine thousand nine hundred ninety one dollars and thirteen cents (\$229,991.13) for Clearway Minnesota Secondhand Smoke 220-479 under Health and Human Services which amends the Total Fiscal Year 2011 Tribal Operations to read: Seventy six million four hundred seventy five thousand seven hundred thirty five dollars and two cents (\$76,475,735.02); and

Fifteen thousand dollars no cents (\$15,000.00) to complete the renovation of the office area in the lower lever of the Government Center to house the TCSE program 280-625; under **Permanent Initiative** which amends the **Total Fiscal Year 2011 Permanent Initiative** to read: Eighteen million five hundred eighty three thousand eight hundred twenty six dollars and fifteen cents (\$18,583,826.15); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2011. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

All funds appropriated are maximum fund amounts and shall not be exceeded.
