Ordinance 32-12

An Ordinance of Supplemental Appropriation for October and November 2011 Tribal Per Capita Distributions for Fiscal Years ending September 30, 11 and September 30, 2012.

The District II Representative introduced the following Bill on the 6th day of October, 2011.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for October and November 2011, Tribal Per Capita Distribution for the fiscal years ending September 30, 2011 and September 30, 2012.

Title I.

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for Bonus Distributions (October and November 2011, see schedule attached) for fiscal years September 30, 11 and ending September 30, 2012.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Ninety thousand dollars and no cents (\$90,000.00) to cover changes in Band Member classifications and anticipated probate adjustments needed under **Bonus Distribution** which amends the **Total Fiscal Year 2011 Tribal Distributions** to read Forty four million two hundred forty thousand nine hundred ninety two dollars and no cents (\$44,240,992.00).

Four million six hundred thirty thousand four hundred seventy nine dollars and no cents (\$4,630,479.00) for Adult distributions, Twenty five thousand dollars and no cents (\$25,000.00) for Administration costs under **Bonus Distribution**; which amends the **Total Fiscal Year 2012 Tribal Distributions** to read Four million six hundred fifty five thousand four hundred seventy nine dollars and no cents (\$4,655,479.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
