

## Ordinance 71-12

An Ordinance of Supplemental Appropriation for August 2012 and September 2012 Tribal Per Capita Distributions and Legislative/Office of Management and Budget for Fiscal Year ending September 30, 2012.

The District II Representative introduced the following Bill on the 24th day of July, 2012.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for August 2012 and September 2012 Tribal Per Capita Distribution for the fiscal year ending September 30, 2012.

### Title I.

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for Bonus Distributions (August 2012 and September 2012, see schedule attached) and Legislative/Office of Management and Budget for fiscal year ending September 30, 2012.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million one thousand fifty six dollars and no cents (\$6,001,056.00) for Adult distributions; Three million nine hundred eighty one thousand six hundred dollars and no cents (\$3,981,600.00) for Minors distribution under **Bonus Distribution** which amends the **Total Fiscal Year 2012 Tribal Distributions** to read: forty nine million six hundred fifty two thousand four hundred twenty four dollars and no cents (\$49,652,424.00) and

Ten thousand dollars and no cents (\$10,000.00) for Administration costs **under Legislative/Office of Management and Budget** which amends the **Total Fiscal Year 2012 Tribal Operations** to read: Eighty eight million two hundred ninety thousand seven hundred sixty one dollars and eighty six cents (\$88,290,761.86).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
