Ordinance 79-12

An Ordinance of Supplemental Appropriation and Budget Transfers for Permanent Initiative, Chief Executive, Circle of Health, Education, Health and Human Services, Natural Resources and Legislative of the Mille Lacs Band Tribal Government for Fiscal Years ending September 30, 2012 and September 30, 2013.

The District I Representative introduced the following Bill on the 11th day of September, 2012.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Years ending September 30, 2012 and September 30, 2013.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Permanent Initiative, Administration, Chief Executive, Circle of Health, Education, Health and Human Services, Natural Resources and Legislative for Fiscal Years ending September 30, 2012 and September 30, 2013.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Fifty thousand dollars and no cents (\$50,000.00) for shortfall within the budget from un-spent net revenue 100-200 under the **Chief Executive**; One million four hundred thousand dollars and no cents (\$1,400,000.00) for Higher Education 201-314 from un-spent net revenue to support college tuition cost under **Education**, Thirty four thousand dollars and no cents (\$34,000.00) for PPG 250-573 EPA grant under **Natural Resources**; Three hundred eighty seven thousand dollars and no cents (\$387,000.00) for budget shortfall 100-140 under **Legislative** which amends the **Total Fiscal Year 2012 Tribal Operations** to read: Ninety two million four hundred sixty one thousand seventy seven dollars and eighty six cents (\$92,461,077.86); and

One million nine hundred thousand dollars and no cents (\$1,900,000.00) for COH 100-233 from earnings under the **Circle of Health Endowment Fund** which amends the **Total Fiscal Year 2012 Circle of Health** to read: Three million six hundred forty two thousand dollars and no cents (\$3,642,000.00); and

Five hundred twenty five thousand dollars and no cents (\$525,000.00) to support the purchase of two land parcels 49 acres near Shakopee Lake and 83 acres near Hinckley under **Permanent Initiative** which amends the Total Fiscal Year 2012 Permanent Initiative to read: Eleven million four hundred thirty one thousand twenty nine dollars and twenty two cents (\$11,431,029.22); and

Two hundred thirty one thousand eight hundred ninety eight dollars and no cents (\$231,898.00) for Pine Grove Leadership Academy 201-307 from un-spent net revenue to support the online schooling option under **Education** which amends the **Total Fiscal Year 2013 Tribal**Operations to read: Seventy three million four hundred fifty eight thousand fourteen dollars and no cents (\$73,458,014.00); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
