## Ordinance 49-12

An Ordinance of Supplemental Appropriation and Budget Revision for Community Development, Education, Health and Human Services, Natural Resources, of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2012.

The District I Representative introduced the following Bill on the 24th day of January, 2012.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Year ending September 30, 2012.

## Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Community Development, Education, Health and Human Services, Natural Resources, for Fiscal Year ending September 30, 2012.

Section 1.01: Two hundred eighty one thousand four hundred nine dollars and no cents for Head Start 201-350 grant fund; Three hundred seventy four thousand one hundred ninety eight dollars and no cents (\$374,198.00) for Early Head Start 201-357 grant funds; Twenty thousand five hundred fifty five dollars and no cents (\$20,555.00) for BGC – MN CAG 201-331 MN Community Action Grant funds; Twenty thousand two hundred five dollars and no cents (\$20,205.00) for BGC – CSBG 201-330 Community Services Block Grant funds; Two hundred dollars and no cents (\$200.00) for BGC 201-319 donated funds under Education; Sixty three thousand six hundred ninety two dollars and no cents (\$63,692.00) Contract Health 220-421 carryover of Self Governance funds under Health and Human Services which amends the Total Fiscal Year 2012 Tribal Operations to read: Seventy five million two hundred sixty two thousand nine hundred six dollars and eighty eight cents (\$75,262,906.88); and

Seventy five thousand dollars and no cents (\$75,000.00) for Water/Wastewater 100-130-4300 to cover the increased cost of painting and repairs to the Vineland Water Tower; Twenty seven thousand thirty eight dollars and fifty cents (\$27,038.50) to cover the additional cost for removal of contaminated soils in DI under **Permanent Initiative** which amends the Total Fiscal Year 2012 Permanent Initiative to read: Two hundred seventy six thousand seven hundred seventy seven dollars and no cents (\$351,777.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.02.1: The Band Assembly hereby authorizes the budget revision of programmatic funds for the following:

<u>FY 2012 – Natural Resources</u>- Budget Revision to move monies within budget (see attachment#3)

DNR MCT Renew Grant (EECBG) 250-523

\$41,403.11

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2012. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

All funds appropriated are maximum fund amounts and shall not be exceeded.
