Ordinance 42-12

An Ordinance of Supplemental Appropriation for Administration, Education, Natural Resources, Department of Justice and Permanent Initiative of the Mille Lacs Band Tribal Government for Fiscal Years ending September 30, 2011 and September 30, 2012.

The District II Representative introduced the following Bill on the 15th day of December, 2011.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Governmental Operations for Fiscal Years ending September 30, 2011 and September 30, 2012.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Education, Department of Justice, Natural Resources, Department of Justice and Permanent Initiative for Fiscal Years ending September 30, 2011 and September 30, 2012.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Eighteen thousand five hundred dollars and no cents (\$18,500.00) to cover deficit contractual amounts from unspent net revenue 100-215 under **Department of Justice**; which amends the **Total Fiscal Year 2011 Tribal Operations** to read: Eighty two million six hundred ninety six thousand five hundred thirty four dollars and one cents (\$82,696,534.01); and

Nineteen thousand eight hundred thirty seven dollars and twenty five cents (\$19,837.25) to fund from 2011 carryover to continue support of the Joint project between MLB Government and NAS Schools in the network infrastructure upgrade 100-225; One thousand seven hundred twenty four dollars and thirty two cents (\$1,724.32) from unspent net revenue to purchase a computer for grant writer under Administration; Six hundred four thousand five hundred twenty dollars and no cents (\$604,520.00) from un-spent net revenue NASS Transportation to purchase seven buses for Nay-ah-Shing Schools 201-326-7100; Eighty seven thousand one hundred three dollars and no cents (\$87,103.00) for Outreach 201-329 FY 2011 carryover to support donation to Onamia Public Schools to assist the district in providing educational programming and necessary staff for the Indian Education Program; One hundred six thousand six hundred fifty four dollars and no cents (\$106,654.00) for Cultural Language Revitalization grant funds 201-371; One thousand dollars and no cents (\$1,000.00) donation of funds from MN National Guard 201-319 under Education; Two hundred forty four thousand four hundred sixty dollars and no cents (\$244,460.00) for continuing grant 220-415; Five hundred thirteen thousand one hundred sixty two dollars and no cents (\$513,162.00) for a continuing grant 220-495 under Health & Human Services; Thirty thousand one hundred forty three dollars and no cents (\$30,143.00) from unspent net revenue DNR Real Estate 250-595 to support electronic records management system for Real Estate; Two hundred thirty thousand seven hundred dollars and no cents (\$230,700.00) from unspent Net revenue to support the clean up in D3 with the purchase of heavy equipment and employ five staff for one year 250-530; Eighty nine thousand six hundred dollars and seventy cents (\$89,600.70) from unspent net revenue to support the purchase of four new department vehicles 250-530 under Natural Resources; which amends the Total Fiscal Year 2012 Tribal Operations to read: Operating on a continuing resolution 14-04-73-11; and One hundred eighty five thousand dollars and no cents (\$185,000.00) for DNR 250-530 to supplement the cost with unspent net revenue to purchase heavy equipment under Permanent Initiative which amends the Total Fiscal Year 2012 Permanent Initiative to read: Two hundred thirty four thousand seven hundred thirty eight dollars and fifty cents (\$234,738.50); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2011. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

All funds appropriated are maximum fund amounts and shall not be exceeded.
