

## Ordinance 06-13

An Ordinance of Supplemental Appropriation for December 2012 and January 2013 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2013.

The District I Representative introduced the following Bill on the 13th day of November, 2012.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for December 2012 and January 2013 Tribal Per Capita Distribution for the fiscal year ending September 30, 2013.

### Title I.

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for Bonus Distributions (December 2012 and January 2013, see schedule attached) and Legislative/Office of Management and Budget for fiscal year ending September 30, 2013.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Eight million five hundred eighty seven thousand two hundred six dollars and no cents (\$8,587,206.00) for Adult distributions; Five million two thousand forty five dollars and no cents (\$5,002,045.00) for Minor distributions under **Bonus Distribution** which amends the **Total Fiscal Year 2013 Tribal Distributions** to read: Eighteen million four hundred eighty six thousand five hundred sixty eight dollars and no cents (\$18,486,568.00) and

Twenty thousand dollars and no cents (\$20,000.00) for Administration costs **under Legislative/Office of Management and Budget** which amends the **Total Fiscal Year 2013 Tribal Operations** to read: Seventy five million three hundred seventy five thousand eight hundred twenty four dollars and ninety two cents (\$75,375,824.92).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:


