### Ordinance 11-13

An Ordinance of Supplemental Appropriation for the Mille Lacs's 1/6 Equal Shares Distribution representing the Nelson Act proceeds from Woodlands/Nelson Act Account for Fiscal Year ending September 30, 2013.

The District II Representative introduced the following Bill on the 27th day of November, 2012.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Mille Lacs's 1/6 Equal Shares Distribution from the Nelson Act proceeds held in the Woodlands/Nelson Act Account for Band Members and Minors, which will be placed in Trust, until the minors reach 18 years of age, for the fiscal year ending September 30, 2013.

### Title I.

Section 1: Mille Lacs's 1/6 Equal Shares Distribution from Nelson Act proceeds: The Band Assembly hereby appropriates and authorizes expenditures for Mille Lacs's 1/6 Equal Shares Distribution from the Nelson Act proceeds, for fiscal year ending September 30, 2013.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two million four hundred fifty one thousand eight hundred twenty dollars and seventy six cents (\$2,451,820.76) for Band Members (minors be placed in Trust) from the Mille Lacs's 1/6 Equal Shares Distribution Trust Account; which amends the **Total Fiscal Year 2013 Nelson Act proceeds from the Woodlands/Nelson Act Account** to read: Three million seven hundred fifty thousand two hundred twenty dollars and seventy six cents (\$3,750,220.76); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

#### Preamble

Be it enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Mille Lacs's 1/6 Equal Shares Distribution from the Nelson Act proceeds held in the Woodlands/Nelson Act Account for Band Members and Minors, which will be placed in Trust, until the minors reach 18 years of age, for the fiscal year ending September 30, 2013.

### Title I.

Section 1: Mille Lacs's 1/6 Equal Shares Distribution from Nelson Act proceeds: The Band Assembly hereby appropriates and authorizes expenditures for Mille Lacs's 1/6 Equal Shares Distribution from the Nelson Act proceeds, for fiscal year ending September 30, 2013.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Two million four hundred fifty one thousand eight hundred twenty dollars and seventy six cents (\$2,451,820.76) for Band Members (minors be placed in Trust) from the Mille Lacs's 1/6 Equal Shares Distribution Trust Account; which amends the **Total Fiscal Year 2013 Nelson Act proceeds from the Woodlands/Nelson Act Account** to read: Three million seven hundred fifty thousand two hundred twenty dollars and seventy six cents (\$3,750,220.76); and
