

Ordinance 28-13

An Ordinance of Supplemental Appropriation for April and May 2013 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2013.

The District III Representative introduced the following Bill on the 3rd day of April, 2013.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for April and May 2013 Tribal Per Capita Distribution for the fiscal year ending September 30, 2013.

Title I.

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for Bonus Distributions (April and May 2013, see schedule attached) and Legislative/Office of Management and Budget for fiscal year ending September 30, 2013.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million five hundred eighty seven thousand seven hundred thirty seven dollars and no cents (\$5,587,737.00) for Adult distributions; Four million eighty five thousand two hundred dollars and no cents (\$4,085,200.00) for Minors under **Bonus Distribution** which amends the **Total Fiscal Year 2013 Tribal Distributions** to read: Thirty three million three hundred seventy seven thousand seven hundred seventy four dollars and no cents (\$33,377,774.00); and

Fifteen thousand dollars and no cents (\$15,000.00) for Administration costs **under Legislative/Office of Management and Budget** which amends the **Total Fiscal Year 2013 Tribal Operations** to read: Eighty one million six hundred sixty four thousand eighty six dollars and eighteen cents (\$81,664,086.18).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
