

Ordinance 21-13

An Ordinance of Supplemental Appropriation for Economic Development for Corporate Commission Capital and Non-Gaming Operations Capital of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2013.

The District II Representative introduced the following Bill on the 28th day of February, 2013.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Economic Development for the Fiscal Year ending September 30, 2013.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Economic Development for Fiscal Year ending September 30, 2013.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Three hundred twenty nine thousand four hundred eighty one dollars and no cents (\$329,481.00) for Corporate Commission Capital; One hundred ninety nine thousand five hundred dollars and no cents (\$199,500.00) for Non-Gaming Operations Capital; Non-Gaming Operating Capital under **Economic Development of the Corporate Commission** which amends the **Total Fiscal Year 2013 Economic Development** to read: Eleven million eighteen thousand one hundred twenty three dollars and no cents (\$11,018,123.00); and

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: All funds appropriated for capital construction projects shall be appropriated to align with the project length so as to automatically carry-over to the next fiscal year if appropriated funds remain and if the project is not completed within Fiscal Year 2013. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, a written Change Order shall immediately be routed to the Band Assembly for appropriate action.

All funds appropriated are maximum fund amounts and shall not be exceeded.

Any funds that are not expended for the purposes identified shall be returned to the Band Government's Economic Development fun.


