Ordinance 43-13

An Ordinance of Supplemental Appropriation, Budget Transfer and Budget Revision to Administration, Community Development, Education, Gaming Regulatory Authority, Health and Human Services, Legislative and Permanent Initiative of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2013.

The District III Representative introduced the following Bill on the 27th day of August, 2013.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Administration, Community Development, Education, Gaming Regulatory Authority, Health and Human Services, Legislative and Permanent Initiative for the Fiscal Year ending September 30, 2013.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Administration, Community Development, Education, Gaming Regulatory Authority, Health and Human Services, Legislative and Permanent Initiative for the Fiscal Year ending September 30, 2013.

Section 1.01: Amendment to Section 1.02. under **Health and Human Services**; Ten thousand dollars and no cents (\$10,000.00) for Donation 100-140-6668 to Lac Courte Oreilles Tribe (LCO) for rebuild of Big Drum Ceremonial Building under **Legislative** which amends the **Total Fiscal Year 2013 Mille Lacs Band Tribal Operations** to read: Ninety five million seven hundred forty five thousand five hundred twenty three dollars and fifty cents (\$95,745,523.50); and

One hundred thousand dollars and no cents (\$100,000.00) for Band Match for IHS 100-126 grant to cover the additional cost for the 900 ft of water main pipe in D1 under Permanent Initiative which amends the Total Fiscal Year 2013 Mille Lacs Band Permanent Initiative to read: Four million five hundred thirty one thousand seventy eight dollars and forty seven cents (\$4,531,078.47); and
