### Ordinance 52-14

An Ordinance of Supplemental Appropriation from Economic Development Fund for earnest funding for Embassy Suites-Oklahoma City, in Oklahoma Investment for Fiscal Year ending September 30, 2014.

### Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for earnest funding for Embassy Suites-Oklahoma City Hotel Investment for the Fiscal Year ending September 30, 2014.

#### Title I

Section 1: Economic Development. The Band Assembly hereby appropriates and authorizes expenditures from Economic Development for Fiscal Year ending September 30, 2014.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five Hundred Thousand and no cents (\$500,000.00) for earnest funding for Embassy Suites-Oklahoma City in Oklahoma Investment under **Economic Development Fund**, which amends the **Total Fiscal Year 2014 Economic Development** to read Fourteen Million, Eight hundred twenty nine thousand, five hundred ninety nine dollars and no cents (\$14,829,599.00).

Section 1.02: Amendment to Section 1.03. The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:
