

**Ordinance 48-14**

An Ordinance of Supplemental Appropriation for the Unclaimed Per Capita Payments of the Nelson Act Proceeds from Woodlands/Nelson Act Accounts for Fiscal Year ending September 30, 2014.

The District II Representative introduced the following Bill on the 28th day of August, 2014.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from the Nelson Act proceeds for the fiscal year ending September 30, 2014.

Title I.

Section 1: Nelson Act proceeds: The Band Assembly hereby appropriates and authorizes expenditures for the Nelson Act proceeds, for fiscal year ending September 30, 2014.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Twenty thousand, seven hundred and no cents (\$2,700.00) for Unclaimed Per Capita Payments under **Nelson Act Proceeds** which amends the **Total Fiscal Year 2014 Nelson Act proceeds** to read: Two thousand seven hundred and no cents (\$2,700.00); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
