

Ordinance 47-14

An Ordinance of Supplemental Appropriation of Unspent Net Revenue for Legislative for the Fiscal Year ending September 30, 2014.

The District I Representative introduced the following Bill on the 14th day of August, 2014.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Legislative for the Fiscal Year ending September 30, 2014.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Legislative for the Fiscal Year ending September 30, 2014.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: One hundred twenty thousand dollars and no cents (\$120,000.00) for three Legislative vehicles for Secretary-Treasurer, Districts II and III 100-7100 from unspent net revenue; Forty thousand dollars and no cents (\$40,000.00) for Legislative Coordinator position 140-4000 under **Legislative** which amends the **Total Fiscal Year 2014 Mille Lacs Band Tribal Operations** to read: One hundred twenty four million one hundred seventy three thousand seventy nine dollars and no cents (\$124,173,079.00); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:
