

Ordinance 36-15

An Ordinance of Supplemental Appropriation for District I Powwow Arena from Permanent Initiative for Fiscal Year ending September 30, 2015.

The District I Representative introduced the following Bill on the 11th day of June, 2015.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating carry over for Repairs to the District I Powwow Arena from Permanent Initiative for the Fiscal Year ending September 30, 2015.

Title I.

Section 1: The Band Assembly hereby appropriates and authorizes expenditures for Repairs to the District I Powwow Arena for Fiscal Year ending September 30, 2015; and

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Sixty seven thousand four hundred eighty one dollars and no cents (\$67,481.00) carry over to 100-107-7200 for repair of MC stand doors, lights, pathway lights, new well pump, water line, Trex deck in drum circle, sonnet tubes, concrete for flagpoles and lights from **Permanent Initiative** which amends the **Total Fiscal Year 2015 Permanent Initiative** to read: Thirteen million three hundred thirty two thousand one hundred sixty five dollars and eighty cents (\$13,332,165.80) and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:

Section 1.03: All funds appropriated for capital construction projects shall be appropriated to align with the project length and will no longer automatically carry-over to the next Fiscal Year. If appropriated funds remain and if the project is not completed within Fiscal Year 2015 capital construction projects shall be re-appropriated. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified so as to take appropriate action.


