An Ordinance of Supplemental Appropriation for Education; Health and Human Services; Natural Resources; and Permanent Initiative for the Fiscal Year ending September 30, 2015; and

for additional Adult Band Member Economic Stimulus Payments from Taxation Account for Fiscal Year ending September 30, 2015.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for Education; Health and Human Services; Natural Resources; and Permanent Initiative for the Fiscal Year ending September 30, 2015; and

from Taxation Revenue for the additional amount needed for Adult Band Member Economic Stimulus Payments for the fiscal year ending September 30, 2015.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for Education; Health and Human Services; Natural Resources; and Permanent Initiative for the Fiscal Years ending September 30, 2015; and

Section 1: Taxation Revenue: Additional needed for Adult Band Member Economic Stimulus Payments. The Band Assembly hereby appropriates and authorizes expenditures for additional needed for Adult Band Member Economic Stimulus Payments –November 2014, from Taxation Revenue, for Fiscal Year ending September 30, 2015.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: Seventy eight thousand five hundred eighty dollars and thirty four cents (\$78,580.34) for DNR General 250-530 of FY14 Carryover from various DNR budgets to support Fisheries Biologist position and program equipment; One hundred seven thousand dollars and no cents (\$107,000.00) for Fire Prep 250-549 of FY2014 Carryover to support increase from part-time seasonal to five (5) full-time seasonal staff with benefits under **Natural Resources**; **Decrease** Thirty four thousand four hundred thirty three dollars and no cents (\$34,433.00) for Crime Victim Services 220-495 per State grant reduced award; Four hundred forty seven thousand six hundred thirty two dollars and no cents (\$447,632.00) for Wrap-Around Program 220-NEW from unspent net Revenue to support funding the program under **Health and Human Services**; Four hundred forty four thousand seven hundred ninety one dollars and no cents (\$444,791.00) for Pine Grove FY2015 budget from Net Revenue; Sixty four thousand two hundred ninety seven dollars (\$64,297.00) for CCDF Mandatory 201-365 grant funds; Fifty seven thousand one five dollars and no cents (\$57,105.00) for CCDF Discretionary 201-366 of grant funds; Thirty seven thousand six hundred forty seven dollars and no cents (\$37,647.00) for

Two hundred sixty five thousand dollars and no cents (\$265,000.00) for acquisition of an approximate 200 acre parcel adjacent to the Wise Owl Development in D3 under **Permanent Initiative**; which amends the **Total Fiscal Year 2015 Permanent Initiative** to read: Two million six hundred ninety nine thousand three hundred thirty dollars and thirty three cents (\$2,699,330.33); and

Thirty thousand dollars and no cents (\$30,000.00) for Additional needed for Adult Stimulus 100-212 under **Taxation Revenue**; which amends the **Total Fiscal Year 2015 Taxation Revenue** to read: Three million one hundred thirty thousand dollars and no cents (\$3,130,000.00); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total programs budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2015. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.05: All funds appropriated for capital construction projects shall be appropriated to align with the project length and shall not automatically carry over to the next Fiscal Year. If appropriated funds remain, and if the project is not completed within Fiscal Year 2014, capital construction projects shall be re-appropriated. If, for any reason, the project length runs over the contracted period for construction causing construction costs to exceed the appropriated amount, the Band Assembly must be notified immediately.

All funds appropriated are maximum fund amounts and shall not be exceeded.
