## Ordinance 53-15

An Ordinance of Supplemental Appropriation and Budget Transfer for the Natural Resources, Administration, Community Development, Health & Human Services, Department of Justice and Education Departments for the Fiscal Year ending September 30, 2015

The District II Representative introduced the following Bill on the 10th day of September, 2015.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing a Budget Transfer for Natural Resources, Administration, Community Development, Health & Human Services, Department of Justice and Education Departments for the Fiscal Year ending September 30, 2015.

## Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures and a budget transfer for Natural Resources, Administration, Community Development, Health & Human Services, Department of Justice and Education Departments for the Fiscal Year September 30, 2015.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: One hundred twenty five thousand dollars and no cents (\$125,000.00) for Real Estate 250-595 of Permanent Initiative Funds to support the purchase of two properties in District 2; Sixteen thousand seven hundred fifty dollars and no cents (\$16,750.00) for Fire Prep 250-549 of Self Governance Funds to cover equipment under Natural Resources; One thousand one hundred fifty eight dollars and no cents (\$1,158.00) for DOL Youth Services 280-675 of Self-Governance Funds for salaries; Eight hundred sixty four dollars and no cents (\$864.00) for DOL Adult Services 280-676 of Self-Governance funds for salaries under Administration; One hundred eight thousand eight hundred fifty six dollars and no cents (\$108,856.00) for Housing Maintenance 270-273 of Housing Rental Income 270-275-3808 to cover Maintenance program salary, fringe and maintenance line items under Community **Development**; Nineteen thousand seven hundred one dollars and zero cents (\$19,701.00) for Social Nutrition 220-406 of Grant Funds for Program Supplies and Kitchen Supplies under Health & Human Services which amends the Total Fiscal Year 2015 Mille Lacs Band Tribal Operations to read: Two hundred forty six million two hundred ninety five thousand one hundred ninety nine dollars and seventy nine cents (\$246,295,199.79); and

Section 1.02.1: The Band Assembly hereby authorizes the budget revision of programmatic funds for the following:

Section 1.03: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total program's budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

Section 1.04: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2015. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

All funds appropriated are maximum fund amounts and shall not be exceeded.
