Ordinance 52-15

An Ordinance of Budget Transfer for Gaming Regulatory Authority of the Mille Lacs Band Tribal Government for Fiscal Year ending September 30, 2015.

The District I Representative introduced the following Bill on the 8th day of September, 2015.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of authorizing a Budget Transfer for Gaming Regulatory Authority for Fiscal Year ending September 30, 2015.

Title I.

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes a Budget Transfer for Gaming Regulatory Authority for Fiscal Year ending September 30, 2015.

Section 1.01: The Band Assembly hereby authorizes the budget revision of programmatic funds for the following:
