Ordinance 51-16

An Ordinance of Supplemental Appropriation for the Education, Natural Resources, Community Development, Health & Human Services and Department of Justice Departments for the Fiscal Years ending September 30, 2016 and September 30, 2017.

The District III Representative introduced the following Bill on the 28th day of July, 2016.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing expenditures for the Education, Natural Resources, Community Development, Health & Human Services and Department of Justice Departments for the Fiscal Years ending September 30, 2016 and September 30, 2017.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Education, Natural Resources, Community Development, Health & Human Services and Department of Justice Departments for the Fiscal Years ending September 30, 2016 and September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Four hundred nineteen thousand two hundred dollars and no cents (\$419,200.00) for State Head Start 201-351 of FY16 Grant Funds as submitted; Two thousand three hundred fifty dollars and no cents (\$2,350.00) for Day Care 201-364 of FY16 PreK-Grade 3 Alignment Grant Funds as submitted; Twenty-one thousand two hundred ninety-three dollars and eighty cents (\$21,293.80) for Child Nutrition Equipment 201-333 of FY16 MN Department of Education Grant Funds as submitted; Sixty-five thousand dollars and no cents (\$65,000.00) for Child Nutrition Summer Food 201-338 of FY16 Unspent/Net Revenue Funds to create a separate budget as per USDA program regulations; Ten thousand seventy dollars and no cents (\$10,070.00) for Enhancement 201-337 of FY16 Grant Funds as submitted; Two hundred seventy-two thousand six hundred seventy-seven dollars and no cents (\$272,677.00) for NASS O&M 201-325 of FY16 Permanent Initiative Funds to support repairs and construction of pavement, floors and bleachers at Nay ah Shing and Abinoojiyag buildings; Thirty-one thousand thirty-one dollars and no cents (\$31,031.00) for NASS O&M 201-325 of FY16 Unspent/Net Revenue Funds to replace storage containers, water fountains and hand dryers at both the Nay ah Shing and Abinoojiyag buildings; Seventy-seven thousand eighty-two dollars and no cents (\$77,082.00) for NASS O&M 201-325 of FY16 Permanent Initiative Funds to support repair & Renovation of the Home Economics room at Nay ah Shing School; Forty-three thousand five hundred ninety-six dollars and no cents (\$43,596.00) for Ojibwe Language 201-335 of FY16 Unspent/Net Revenue Funds to support an Ojibwe Language Coordinator position which was previously eliminated and funding removed from the biennium budget under Education; Eighteen thousand four hundred eighty-one dollars and no cents (\$18,481.00) for Real Estate 250-595 of FY16 Unspent/Net Revenue Funds to support contracting costs with Houston Engineering for GIS Server upgrade, technical assistance and other updates to system; Forty-five

Four hundred seven thousand three hundred eighty-eight dollars and no cents (\$407,388.00) for Law Enforcement 100-160 of FY17 Unspent/Net Revenue Funds to support the newly created Tribal Police Call Center under **Department of Justice**; Eighty-five thousand seventeen dollars and no cents (\$85,017.00) for Ojibwe Language 201-335 of FY17 Unspent/Net Revenue Funds to support an Ojibwe Language Coordinator position which was previously eliminated and funding removed from the biennium budget under **Education** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: One million six hundred ninety-one thousand six hundred thirty-three dollars and no cents (\$1,691,633.00);

Section 1.03: All funds appropriated for federal, state and private grant funds shall be appropriated to align with the grant term so as to automatically carry-over to the next Fiscal Year if appropriated funds remain and if the grant is not completed within Fiscal Year 2016. If, for any reason, the grant term runs over the original end date causing costs to exceed the original appropriated amount, the Band Assembly must be notified so as to take appropriate action. In addition, Band Assembly hereby appropriates and authorizes the expenditure of all federal, state and private grant funds only after receipt by Band Assembly, of signed award letter from grantor agency.

Section 1.04: The Band Assembly hereby authorizes Commissioners to approve budgetary revisions within programs <u>up</u> to \$10,000.00 provided that the revisions are allowable under grant provisions, if applicable and that sufficient funds are available for the revision. For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total program's budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
