

Ordinance 48-16

An Ordinance of Supplemental Appropriation for August and September 2016 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2016.

The District III Representative introduced the following Bill on the 19th day of July, 2016.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of authorizing and appropriating for August and September 2016 Tribal Per Capita Distribution for the Fiscal Year ending September 30, 2016.

Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorized expenditures for Tribal Per Capita Distributions (August and September 2016, see schedule attached) for Fiscal Year ending September 30, 2016.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Six million one hundred seventy-two thousand seven hundred twenty-eight dollars and no cents (\$6,172,728.00) for Adult Distributions 100-198-6668 of FY16 Bonus Distribution Funds; Four million one hundred ninety-seven thousand two hundred dollars and no cents (\$4,197,200.00) for Minor Distributions 100-198-6668 of FY16 Bonus Distribution Funds; Five thousand dollars and no cents (\$5,000.00) for Admin costs 100-198-4550 (August and September 2016) of FY16 Bonus Distribution Funds under **Bonus Distribution** which amends the **Total Fiscal Year 2016 Mille Lacs Band Tribal Operations** to read: Two hundred fifty-two million four hundred eighty-one thousand two hundred eighty dollars and thirty-six cents (\$252,481,280.36) and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
