It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating and authorizing an expenditure for the Community Development, Natural Resources, Health & Human Services and Legislative Departments for the Fiscal Year ending September 30, 2016.

Title I

Section 1: Governmental Operations. The Band Assembly hereby appropriates and authorizes expenditures for the Community Development, Natural Resources, Health & Human Services and Legislative Departments for the Fiscal Year ending September 30, 2016.

The Band Assembly hereby appropriates and authorizes the expenditures of: One million six hundred twenty-four thousand two hundred twenty-four dollars and no cents (\$1,605,224.00) for IHBG 270-290 of FY16 US HUD Funds for the 2016 Indian Housing Block Grant Funds as submitted; Eight million seventy-four thousand seven hundred thirty-three dollars and no cents (\$8,074,733.00) for Housing Initiative 100-235 of FY16 Housing Initiative Funds for new projects proposed for FY16 as well as some projects that were in process for FY15 but not yet obligated by contract as of 9/30/15; Three million five hundred fifty-five thousand dollars and no cents (\$3,550,000.00) for Home Loan 100-234 of FY16 Housing Initiative Funds for 20 new home loans and 10 home renovation loans; Three hundred thousand dollars and no cents (\$300,000.00) for Elder Housing 270-270 of FY16 Housing Initiative Funds for the completion of elder or disabled renovation projects under Community Development; Eleven thousand dollars and no cents (\$11,000.00) for Real Estate 250-595 of FY16 Permanent Initiative Funds for the purchase of approximately .18 acres in Port Mille Lacs, Lot 324; One hundred ten thousand dollars and no cents (\$110,000.00) for Real Estate 250-595 of FY16 Permanent Initiative Funds to support the purchase of an approximate 1.54 acres of lakeshore property in Wahkon under Natural Resources; Seventy-two thousand sixty-two dollars and no cents (\$72,062.00) for Behavioral Health 220-NEW of FY16 Grant Funds for salary, vehicle maintenance, training and training materials; Twenty-two thousand eight hundred fifteen dollars and no cents (\$22,815.00) for Elder Nutrition 220-406 of FY16 Older Americans Act Title VI Grant Funds as submitted under Health & Human Services: Twenty-three thousand two hundred sixty dollars and no cents (\$23,260.00) for DMV 100-141-4300 of FY16 Permanent Initiative Funds for the Minokaw Technologies to implement and assist the information technology needs of the Department of Motor Vehicles which amends the Total Fiscal Year 2016 Mille Lacs Band Tribal Operations to read: One hundred ninety-eight million five hundred fifty-seven thousand sixty-nine dollars and ten cents (\$198,557,069.10); and

For revisions <u>over</u> \$10,000.00, the Band Assembly hereby authorizes the Administration Policy Board to approve budget revisions within programs of <u>up</u> to 50% of the total program's budget within a given budget line if the program is <u>under</u> \$100,000.00 and <u>up</u> to 20% if the program is \$100,000.00 or greater.

All funds appropriated are maximum fund amounts and shall not be exceeded.
