

Ordinance 29-16

An Ordinance of Supplemental Appropriation from the Economic Development Fund for the renovations at South Mille Lacs Super Stop (formerly Meleen's) for Fiscal Year ending September 30, 2016.

The District III Representative introduced the following Bill on the 5th day of April, 2016.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the renovations at South Mille Lacs Super Stop (formerly Meleen's) for the Fiscal Year ending September 30, 2016.

Title I

Section 1: Economic Development. The Band Assembly hereby appropriates and authorizes an expenditure from the Economic Development Fund for Fiscal Year ending September 30, 2016.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of: Two million seventy-two thousand dollars and no cents (\$2,072,000.00) for the renovations at South Mille Lacs Super Stop (formerly Meleen's) under the **Economic Development Fund**, which amends the **Total Fiscal Year 2016 Economic Development Fund** to read: Eleven million seven hundred thirty-four thousand nine hundred thirty dollars and no cents (\$11,734,930.00).

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental programmatic funds for the following:




