## Ordinance 57-16

An Ordinance of Supplemental Appropriation for October and November 2016 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2017.

The District II Representative introduced the following Bill on the 20<sup>th</sup> day of September, 2016.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of authorizing and appropriating for October and November 2016 Tribal Per Capita Distribution for the Fiscal Year ending September 30, 2017.

## Title I

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorized expenditures for Tribal Per Capita Distributions (October and November 2016, see schedule attached) for Fiscal Year ending September 30, 2017.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million four hundred six thousand seven hundred thirty-five dollars and no cents (\$5,406,735.00) for Adult Distributions 100-198-6668 of FY17 Bonus Distribution Funds; Five thousand dollars and no cents (\$5,000.00) for Admin costs 100-198-4550 (October and November 2016) of FY17 Bonus Distribution Funds under **Bonus Distribution** which amends the **Total Fiscal Year 2017 Mille Lacs Band Tribal Operations** to read: Seven million three hundred twenty-eight thousand nine hundred twenty-five dollars and no cents (\$7,328,925.00) and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
