An Ordinance of Supplemental Appropriation for Adult Band Member Supplemental Economic Payments from Unspent Net Revenue for Fiscal Year ending September 30, 2016.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from Unspent Net Revenue for Adult Band Member Supplemental Economic Payments for the fiscal year ending September 30, 2016.

Title I

Section 1: Unspent Net Revenue: Adult Band Member Supplemental Economic Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments, from Unspent Net Revenue, for Fiscal Year ending September 30, 2016.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditure of : Three million one hundred ninety-seven thousand dollars and no cents (\$3,197,000.00) of FY16 Unspent/Net Revenue for Adult Band Members \$1,000 each (18 years and older, effective August 19, 2016) Supplemental Economic Payments, under **Unspent/Net Revenue**; which amends the **Total Fiscal Year 2016 Mille Lacs Band Tribal Operations** to read: Two hundred forty-two million five hundred sixty-nine thousand one hundred sixty dollars and thirty-six cents (\$242,569,160.36); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
