Ordinance 07-16

An amended Bill of Supplemental Appropriation for December 2015 and January 2016 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2016.

The District I Representative introduced the following Bill on the 24th day of November, 2015.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating for December 2015 and January 2016 Tribal Per Capita Distribution for the fiscal year ending September 30, 2016.

Title I.

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby appropriates and authorizes expenditures for Bonus Distributions (December 2015 and January 2016, see schedule attached) for fiscal year ending September 30, 2016.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Three million nine hundred ninety thousand one hundred sixty-one dollars and no cents (\$3,990,161.00) for Adult Distributions 100-198-6668; Three million three hundred thirty-nine thousand five hundred fifty-nine dollars and no cents (\$3,339,559.00) for Minors Distributions 100-198-6668; Five thousand dollars and no cents (\$5,000.00) for Admin costs 100-198-4550 (December 2015 and January 2016) under Bonus Distribution which amends the Total Fiscal Year 2016 Tribal Distributions to read: Twelve million five hundred ninety-eight thousand one hundred eight dollars and no cents (\$12,598,108); which also amends the Total Fiscal Year 2016 Mille Lacs Band Tribal Operations to read: Fourteen million eight hundred forty-six thousand one hundred forty-seven dollars and thirty-three cents (\$14,846,147.33) and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
