Ordinance 08-16

An amended Bill of Supplemental Appropriation for Adult Band Member Economic Supplemental Payments from Unspent/Net Revenue for Fiscal Year ending September 30, 2016.

The District II Representative introduced the following Bill on the 24th day of November, 2015.

Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of appropriating from Unspent Net Revenue for Adult Band Member Economic Supplemental Payments for the fiscal year ending September 30, 2016.

Title I.

Section 1: Unspent Net Revenue: Adult Band Member Economic Supplemental Payments. The Band Assembly hereby appropriates and authorizes expenditures for Adult Band Member Economic Supplemental Payments, from Unspent Net Revenue, for Fiscal Year ending September 30, 2016.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of Unspent Net Revenue of: Three million seventy five thousand dollars and no cents (\$3,075,000.00) for Adult Band Members \$1,000 each (18 years and older, effective December 3, 2015); Ninety-one thousand (\$91,000.00) for 18 Yr. old Minors; Two million nine hundred ninety-two thousand six hundred one dollars and no cents (\$2,992,601.00) for FY15 Per Cap funds not earned; Five thousand dollars and no cents (\$5,000.00) for Administrative costs for Supplemental Economic Payments, under Unspent/Net Revenue; which amends the Total Fiscal Year 2016 Unspent/Net Revenue to read: Six million five hundred eighteen thousand seven hundred eighteen dollars and thirty-three cents (\$6,518,718.33); which also amends the Total Fiscal Year 2016 Mille Lacs Band Tribal Operations to read: Twenty-two million fifty-seven thousand eight hundred forty-three dollars and thirty three cents (\$22,057,843.33); and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
