## 38-16

An Ordinance of Supplemental Appropriation for June and July 2016 Tribal Per Capita Distributions for Fiscal Year ending September 30, 2016.

The District I Representative introduced the following Bill on the 19<sup>th</sup> day of May, 2016.

## Preamble

It is enacted by the Band Assembly of the Mille Lacs Band of Ojibwe for the purpose of authorizing and appropriating for June and July 2016 Tribal Per Capita Distribution for the fiscal year ending September 30, 2016.

Title I.

Section 1: Tribal Per Capita Distributions. The Band Assembly hereby authorizes expenditures and appropriates for Tribal Per Capita Distributions (June and July 2016, see schedule attached) for fiscal year ending September 30, 2016.

Section 1.01: Amendment to Section 1.02. The Band Assembly hereby appropriates and authorizes the expenditures of: Five million five hundred eighty-seven thousand seven hundred thirty-seven dollars and no cents (\$5,587,737.00) for Adult Distributions 100-198-6668 of FY16 Bonus Distribution Funds; Five thousand dollars and no cents (\$5,000.00) for Admin costs 100-198-4550 (June and July 2016) of FY16 Bonus Distribution Funds under **Bonus Distribution** which amends the **Total Fiscal Year 2016 Bonus Distributions** to read: Thirty-three million eight hundred sixteen thousand one hundred seventeen dollars and no cents (\$33,816,117.00); which also amends the **Total Fiscal Year 2016 Mille Lacs Band Tribal Operations** to read: One hundred eighty-four million seven hundred eighty-seven thousand nine hundred seventy-five dollars and ten cents (\$184,787,975.10) and

Section 1.02: The Band Assembly hereby appropriates and authorizes the expenditure of supplemental funds for the following:
